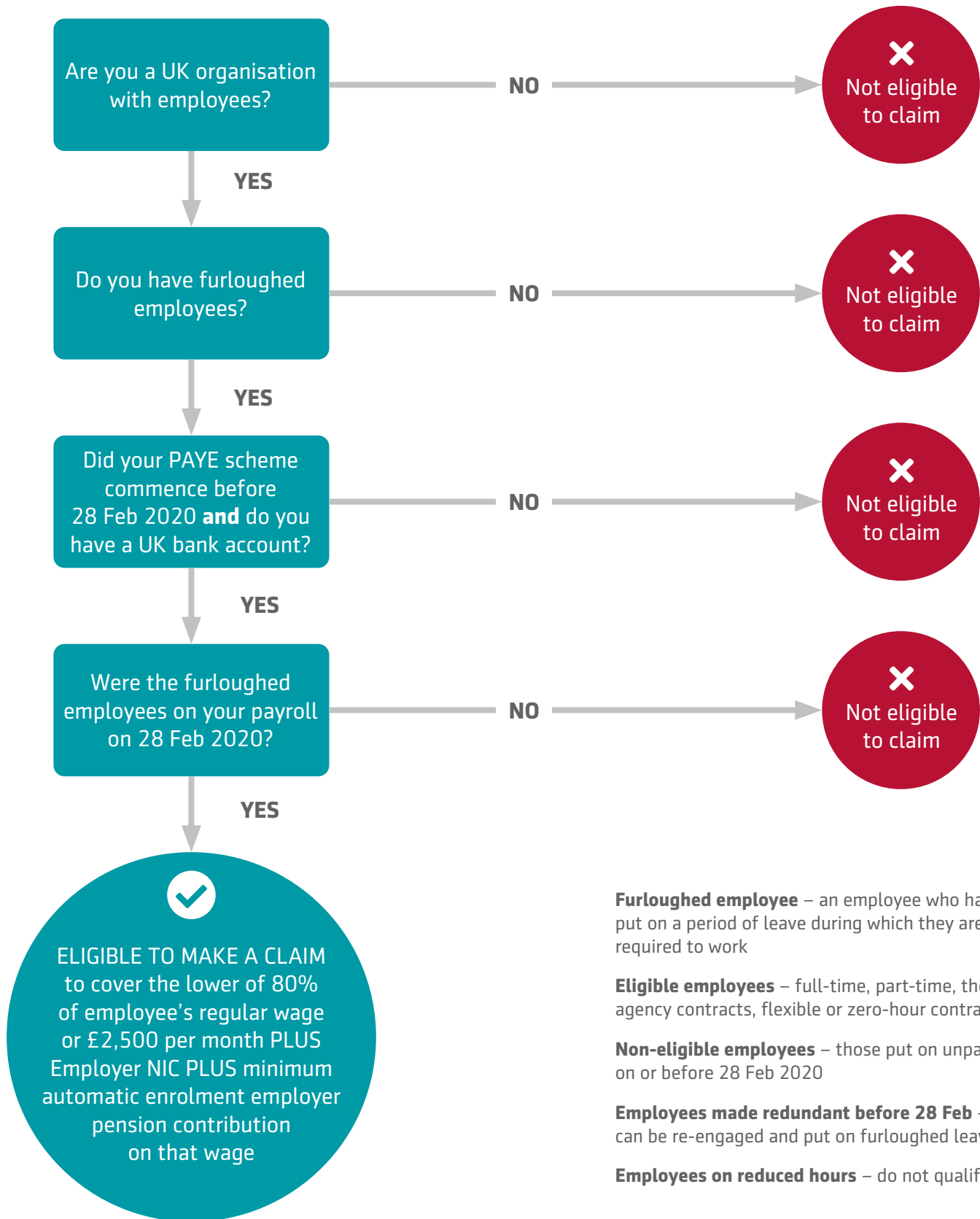


Coronavirus Job retention scheme: eligibility



Furloughed employee – an employee who has been put on a period of leave during which they are not required to work

Eligible employees – full-time, part-time, those on agency contracts, flexible or zero-hour contracts

Non-eligible employees – those put on unpaid leave on or before 28 Feb 2020

Employees made redundant before 28 Feb – can be re-engaged and put on furloughed leave

Employees on reduced hours – do not qualify
